



Dear clients,

On September 18, 2006 our company introduced a new system and rules for registration and support of domain names within the zone (top-level domain, TLD) .bg.

In order to expand the capacity for registration of domain names in the top-level domain .bg and at the same time to improve the quality of our service, during the past three years Register.BG Ltd. has designed and developed a new system for registration and support of domain names.

The new system shall allow our clients for:

- on-line application and reservation of domain name;
- on-line registration of domain name /when a digital signature certificate is used/;
- on-line setup /saving or amending part of the attributes for applied domain - name servers and technical contacts/;
- on-line domain management /initiating, terminating or selling of domain name – by using a digital signature certificate/;
- on-line payment.

The new system shall allow agents between end-users and the registry in the process of registering domain names, so-called Registrars, to operate either as usual, or to manage virtual portals or even to create their own portals for automatic application for, registration and support of domain names.

Due to the high complexity of the system, we plan to implement it at several stages.

In addition to the implementation of the new system, Register.BG Ltd. expands the levels for domain names, while preserving the usual possibility to register domain names in the top-level domain .bg.

The new sub-zones (second-level domains) are as follows:

New rules shall apply for registration of domain names in the sub-zones, and the most important one is that no grounds shall be asked for choice of labels. Clients shall have infinite possibilities to select labels, under condition that such names are not registered, reserved or forbidden.

The registration and support fee for domain names in the top-level domain .bg is reduced, as the initial registration fee is cancelled.

The registration and support fee for domain names in the new sub-zones is significantly lower than the one in the top-level domain .bg.

We are confident that by implementing the new system and rules, Register.BG shall possess a state-of-the-art system REGISTER - REGISTRAR - REGISTRANT (CLIENT) with expanded and deepened opportunities for domain name registration.

The implementation of the new system and rules shall satisfy to a maximum degree the contradictory requirements, arising during the process of domain name registration.

This means that registration of domain names in the top-level domain .bg, shall be sufficient for exposing grounds for labels. This approach shall help to protect intellectual property of the participating subjects.

At the same time there is a variety of sub-zones, where anyone may register a randomly selected domain name.

The registrant's identification requirements are still operative. This approach shall help to avoid anonymous domain names existing in the zone .bg and the sub-zones. A parallel option shall allow clients to identify themselves using a digital signature certificate. Traditional application handling shall remain in force.
